Cost

The test fee is \$129 + GST per person. This includes your ConstructSafe ID card and also includes one re-sit immediately following if you fail your first attempt.

Run at our venue, or yours

Up to 10 attendees at a time can undertake the test at our venue (14 Harrow St, Dunedin).

We can also come to you, provided you have a room and wireless internet connection available that meet the minimum ConstructSafe requirements. Minimum attendee numbers may also be required for this option.

Test information

Each attendee must bring ONE of the following ID types (otherwise no test can be provided)

- NZ Driver licence
- NZ Fire arms licence
- Passport
- If you do not have the above ID, you must advise us of this at the time of booking

Average duration is approximately 45-60 minutes, but candidates may take as little or as much time as they need. The duration depends on factors such as literacy skills, level of knowledge, confidence and ability to use the technology.

ID cards are sent to TMC Ltd by ConstructSafe within 14 days of the test. These will then be forwarded on to the postal address provided at the time of booking so please allow up to 21 days to receive your card.

Category	Question	Answer
General	Does ConstructSafe replace the Site Safe Passport?	No. A Site Safe passport is evidence of training. ConstructSafe independently verifies competency so it complements training.

ConstructSafe Tier 1 – Foundation Health and Safety Competence Putting Competency into the Heart of Construction

From the 1st of July 2017 the NZ Transport Agency mandates the minimum Entry requirement of ConstructSafe Tier1: Foundation Health and Safety Competence (or alternative approved independent competency assessment scheme aligned to ConstructSafe) for entry across all contracts/work sites on State Highways. This requirement relates to both NZ Transport Agency sites and third party work sites on State Highways such as utilities, maintenance related to local council activities, construction works, and events.

The Transport Agency has adopted the ConstructSafe testing scheme as a principal's requirement. This was advised to industry via the NZTA Highways Information Portal in June 2016 via Technical Advice Note TAN #16-05. This can be found under Section 3 at:

Workers entering any State Highway worksite who have not attained ConstructSafe Tier 1 will not be authorised to enter, or alternatively must be supervised at all times while on site by a ConstructSafe Tier 1 competent person.

We recognise that everyone – clients, employers and workers – need to be confident that those working on site are competent and safe to do so.

By implementing ConstructSafe we are introducing a consistent and transparent way to independently check the competency of any worker, trade specialist, supervisor, or manager on site, regardless of their employer. It provides everyone with reassurance that those working on site are competent and safe.

Key messages are:

- *ConstructSafe provides a consistent and transparent way to independently check the competency of any person on site, regardless of their employer.*
 - *It provides reassurance that those that are working on site are competent and safe to do so.*
- *ConstructSafe is not a training course; it helps us to ensure that training programmes meet the needs of our industry.*
- *The objective of ConstructSafe is to be the national standard for health and safety competency in the construction industry.*
- *ConstructSafe was developed by industry, for industry.*

- *The ConstructSafe scheme is delivered through the Construction Safety Council, New Zealand's lead body in health and safety for the construction industry.*
- *The scheme is an online test that assesses health and safety competency of those who work on site.*
- *The Construction Safety Council has mobile test centre that will travel to your site or place of work and carry out testing.*

The ConstructSafe competency assessment scheme provides the construction industry with a framework for individuals to prove health and safety competence. It allows sites to reduce the potential for untrained or inexperienced workers from creating hazardous situations for themselves or others. It helps raise the health and safety standards and creates a safer and more competent New Zealand workforce.

The Transport Agency has adopted the ConstructSafe competency testing scheme as a principal's requirement. Should a supplier wish to advance an alternative that provides the same levels of assurance, the Transport Agency may be prepared to accept such a system. However, the preference is a universal adoption of ConstructSafe. There will be a 12 month implementation period starting from 1 July 2016. Once the implementation period is over all state highway projects/work sites will be expected to have set a minimum entry requirement of ConstructSafe Tier 1 (Foundation Health and Safety Competence) for all workers entering the site. Workers entering the site who have not attained Tier 1 competency will not be authorised to enter the site or must be supervised at all times.

Implementation:

From 1 July 2016 the NZ Transport Agency has adopted the ConstructSafe competency testing scheme as a principal's requirement. A 12-month implementation period commences from this date to allow organisations time to plan and deliver ConstructSafe competency testing to their workers.

From 1 July 2017 the NZ Transport Agency mandates the minimum requirement of ConstructSafe Tier 1 for entry across all contracts/work sites.

These clauses have been updated in the current physical works and professional services contract proforma (March 2016 issue).

For any contracts currently out to tender or currently underway, a Notice to Tenderer or Notice to Contractor as appropriate, shall be issued to incorporate the following clause within the contract. Claims for variation to contract will be based on average reported numbers of personnel entered into the Zero Harm Reporting Portal for 1 December 2016 – 31 May 2016 inclusive.

Workers entering the site who have not attained ConstructSafe Tier 1 are not authorised to enter the site or must be supervised at all times while on site.
